### **PAYMENT TERMS**

We are not responsible for any changes in visa process enforced by German consulate. Client needs to comply with the rules, if he gets rejection due to not complying with rules even after getting instruction from our end.

We will not wait more than 7 Days to deposit the cheque after visa approval. Any loss or bank charges due to delay in payment will be beared by the client.

### **INSURANCE AGAINST VISA REJECTION:**

We would cover cost of our client by providing an compensation of Rs 25,000/-, if his/her visa get rejected and we have mentioned break down of maximum cover in each category :

- Visa Fee : Rs 8,000/-
